City Manager Jennifer Phillips addressed Ms. Nistrand's comments.

MOTION: Councilmember Agnew moved to authorize the City Manager to Amend the Progressive Design Build Agreement with BNBuilders/Miller Hall Partnership, per Phase 2

Amendment in the amount not to exceed \$28,185,289.64.00 plus applicable Washington State Sales Tax (estimated to be \$2,887,140.48.00). Deputy Mayor Zornes second. The motion carried 7-0.

MOTION: Councilmember Agnew moved to approve inclusion of the Emergency Coordination Center as part of the Phase 2 Amendment and GMP as listed above. Councilmember Duerr second. The motion carried 7-0.

AMENDMENT: Councilmember Agnew moved to increase the fire impact fee increase from the proposed 50% to 75% and to increase the loan from the general fund and decreased the unreimbursed general fund contribution.

Councilmember Duerr second. Discussion ensued. The motion carried 7-0.

MOTION: Councilmember Duerr moved to approve additional project funding in the amount of \$2,483,697.00 by adopting the following and to include the amendment above:

We know that the objectives of SMART is for impartial oversight, but how can we as members of the community be confident that a task force led by the Snohomish County Sheriff and a group that is a part of law enforcement can truly be independent investigators? As well, I understand that though, one of the police officers is still under investigation, he has been returned to duty as usual. Please understand that this is psychologically distressing and a potential physical danger to residents of our city, especially for BIPOCs who may live here or are visiting our town. As a concerned BIPOC resident of Bothell, I urge and request your attention and direction on this very troublesome and important matter.

I would also like to hear some updates on the DEI position that was promised. Can more information be provided for us to have an idea on what has been mapped out and what we can expect? The more information shared and discussed with the public, the better we are residents can better trust the process, the Council, the city and all decisions going forward.

Written Statement to Bothell City Councilmembers, 2/2/2021, from Kathy Sharp, Bothell citizen

I will be attending the City Council meeting this evening. My particular concern is the lack of substantive reporting from the City regarding the killing of Juan Rene Hummel, a Black man, by a City of Bothell police officer last summer.

For background about me, my husband was an FBI Agent for 25 years, serving many of those in the Greater Puget Sound area. He carried a weapon every day, wherever he went, all 25 years. This week, two FBI agents were killed during an arrest, and five more wounded. I have deep respect and empathy for law enforcement.

But the fatal shooting of Juan Rene Hummel seems both suspicious and unnecessary. The officer came to a suburban neighborhood because a resident "suspected" car prowling. No evidence. No threats of violence. The officer shows up, without back up, sees a Black suspect, and—in what was a non-violent incident, the suspect is killed. Officers are called to protect the peace, not become executioners. The officer had several choices: 1) go to the scene with another officer 2) request back-up, if indicated 3) walk the confrontation back to do further investigation. No one's life was immediately in danger, requiring lethal use of force.

I remember last May attending my first entirely peaceful Black Lives Matter, family-friendly walk/march, attended graciously by several friendly Bothell police and some supportive elective officials. I felt no fear or suspicion of the Bothell Police then or ever. But then, last summer we had two, close-in-time incidents of Bothell Police firing on Black men suspected of non-violent crimes. Neither crime warranted any guns drawn, just because suspects resisted arrest. In the first incident, a Bothell policeman unintentionally fatally shot another Bothell policeman during the chase. Attorneys believed they could charge the Black suspect with murder, because the policeman would not have shot the other policeman if he had not resisted. Such a scapegoating would be ludicrous if it were not being taken seriously.

As a citizen of Bothell, I want to hear the details of the investigation—or at least a progress report on the investigation, including an explanation of why it is taking so long—and I want to know what kind of training and review is happening within the Bothell Police Department in the meantime. These tragic deaths could have been avoided. We need to learn from them and take responsibility for them—including being honest, transparent and caring with the Hummel family.
